EEAC CONTINUES TO GROW

The Environmental Education Advisory Council is a group of volunteer professionals in active support of environmental education in New York City. Formed as a direct result of the 1974 Mohonk Conference on Outdoor Education for New York City, the Council has grown to include over 200 individuals from the City's key educational institutions and organizations. Today over 40 groups are involved.

Since its formation, the EEAC has published three brochures: a report on the 1974 conference; <u>The Art of Trip-Taking, a</u> <u>Guide to Day-Use Facilities In and Around</u> <u>New York City</u>; and <u>A Guide to Residential</u> <u>Facilities for Environmental Education In</u> <u>the New York Metropolitan Area</u>. It has surveyed professional training programs offered in the City. EEAC also takes part in conferences and environmental fairs and offers environmental education training programs for teachers and administrators in school districts throughout the City.

The Council acts as a citywide clearinghouse for environmental education information, providing an on-going forum for the exchange of ideas and methods. It strives to bring together and support existing environmental education programs in cooperative and complementary efforts in all five boroughs.

For members, EEAC offers a monthly newsletter featuring articles on the City's many exciting environmental education programs and upcoming events, periodic informational mailings, and citywide APRIL 1978

conferences of environmental educators exploring the state of the art. Annual dues (covering the period from April 31 through May 1 of the following year) are \$10.00.
